 - The NSGO director must have access to the NOAA Administrator
 - After 40 years, it is time to reinvent the Sea Grant Program

Insights of the CORE President (RADM West)

- CORE's top priorities in the Federal budget are

 - NOAA (level funded for the first time)
 - NASA (did ok, relatively speaking, flat funding)
- There is turmoil in the ocean budget
- NOAA has little funding to move around
- VADM Lautenbacher can ask for a supplement but won't receive one
- The oceans have no champions in Congress
- This year is important for the FY08 budget; the FY07 budget is done
- NOAA is extremely important to the oceans
- NOAA should get more involved in ocean observing
- Advice to the Panel
 - Need to get the message out that Sea Grant is a good investment in public money

- Sea Grant is viewed as a closed program
- Two big issues to attack are
 - budget growth
 - program review process
- Get involved in ocean education/literacy so constituents care about the oceans
 Teachers need to be educated about ocean science
- The OC recommended that \$1.3B be invested in ocean research
- The FY06 budget provided a total of \$630M for ocean research

NSGO Staff Updates

National Media Relations Center (Ms. Krauk)

- A Media Relations position description has been drafted
- Under a cooperative agreement, NASULGC will host the Media Relations office
- The position was supposed to be filled in 2006; it is now on hold
- Filling this position is critically important to the network

Panel Website (Ms. Krauk)

- The Panel pages of the Sea Grant Website were added April 2005
- Ms. Bucci, a part time Webmaster, was hired in October 2005
- "Green Book" information is now on the Website
- The Panel suggested that the <u>Biennial Report</u> be put online
- Publication of the 2004-2005 Biennial Report is projected for next summer

Regional NSI (Dr. Cammen)

- Funding will probably not be available for the Regional NSI
- NSI was initiated to develop a regional NOAA agenda for ecosystem research
- Regions were derived from the Regional Marine Research Program
- Sea Grant programs within each region were asked to work together to submit two to five year proposals by February 9, 2006

Partnership NSI (Dr. Cammen)

- \$1.5M of Sea Grant funds are not available for the Partnership NSI
- \$1M in funds committed from other NOAA programs will be lost
- Loss of the Partnership NSI is setting the Sea Grant Program back

Performance Measures (Dr. Cammen)

- OMB and Congress requested measures to show the return on their investment in the Sea Grant Program
- Measures will
 - feed into the budget process
 - be annually reported with future targets (one to five years)
- Programs are asked to include measures in their Annual Reports
- NSGO will develop guidance for programs to report measures

EPA/SG Sustainability Teams (Dr. Murray)

- NSGO and EPA issued a request for applications
- Programs were asked to
 - work with local communities
 - develop smart growth projects for implementation
- Three smart growth projects were selected for inclusion in the 2006 omnibus
 - Depot Brook Smart Development Project (Maine Sea Grant)
 - Implementing Smart Growth Principles along the Highway 55 Corridor in Pamlico County (North Carolina Sea Grant)
 - Houston's Midtown: A Transit-oriented Community (Texas Sea Grant)
- Funding may be withdrawn for a second request for applications

FY06 Budget (Mr. Eigen)

- No shortfalls anticipated for FY06 funding of Sea Grant programs because national programs were eliminated
- If the budget remains level, there will be a shortfall of \$3.8M in FY07
- The real issue is the FY07 budget, which OMB could make even lower

NOAA-Grants-Online (Mr. Eigen)

- The new grants-online system is working relatively well
- Within a year, all of NOAA grants will be online using no paper
- Thanked Dr. Kramer for his fiscal officer's involvement in the online pilot project

Assembly of Sea Grant Extension Program Leaders Report (Dr. Hurley)

- The Assembly's Extension Executive Committee is attempting to develop a more active and organized organization through
 - Holding one meeting annually in conjunction with the SGA
 - Expanding conference call participation to include
 - coordinators from each Sea Grant region
 - NSGO, SGA, and Panel liaisons
 - Continuing to support the Beltway Brown Bag initiative
 - Supporting the development of the Sea Grant Extension Academy
 Having the Assembly Chair serve concurrently with SGA Chair
